Presentation by Topsail Beach Fire Department

- Reviewed Fire Safety
- Prevent Fire: Biggest cause of fire is cooking related. Grilling is a major cause.
- Not allowed to grill on decks, especially upper ones.
- Ensure propane tanks are in good shape
- 30 years ago, 17 mins to get out of a house fire, now in 2019 it's 3-5 minutes!!!!
- Check smoke alarms recommend the
- Exit points clear and open
- Close your doors when you are sleeping, interior doors can protect you from fire.
- Recommend annual cleaning of dryer vents (should be addressed by HOA and SS)
- Fire Extinguishers are critical and should be kept up to date
- Lt Feely will send the code to Kim to be distributed to the community

Special Assessment Review

- Report provided to community with full transaction detail
- Community should expect to pay the 3rd assessment
- WWTP expense not included in the budget due to the state required need to raise the risers (22K)
- Beach re-nourishment: Bill Adam's suggest we request that Queen's Grant be serviced first
- Owner suggested that we request help from the town to plant sea oats and place sand fencing in exchange for the utilization of the pipe

- Dredging starts December 15th
- Assessment: Insurance Addendum needs to be rectified by December before KMQ contract for Assessment Project Manager ends.
