- Insurance Claim
 - Denied at first
 - Zach is going to follow up insurance seemed optimistic
 - Get policy documentation from Zach Jeremy to ask for documentation of policy and ask status of claim
 - Received letter from FEMA Jeremy to scan and forward to board to review
- WWTP field status
 - Pipe ripped up; tilled (May); new pipe installed; need tarping (suggested by State of NC)
 - Jeremy to supply board the Sanderson list
 - Needs to be addressed
 - Weed eat immediately; and tarp; should be no vegetation
 - Should be with hoe to till
- Clubhouse Erosion
 - Gutters, downspouts, piping, and landscape to be done in the next few weeks
